**Concrete Municipal Code 13.20.010:** (1) The owner(s) of all houses, buildings, or properties used for human occupancy, employment, recreation, or other purposes, for which a building permit for new construction is applied for after December 31<sup>st</sup>, 2000, situated within the town, or within the unincorporated urban growth area of the town of Concrete as defined by RCW 36.70a.030 if this section is applied by Skagit County to the unincorporated urban growth area, is required at the owner(s)' expense to install suitable toilet facilities and connection to potable water supply therein, to connect such facilities directly with the proper public sewer and public water supply, and to construct any needed system extensions in accordance with the ordinances, resolution and plans of the town, and the direction of the town engineer or his designee.
